Notice is hereby given that in pursuance of a Resolution of the Board of Commissioners in the County of Allen, Ohio, passed on the 1st day of February, 2018 there will be submitted to a vote of the people of said subdivision at a Primary Election to be held in the County of Allen, Ohio, at the regular places of voting therein, on the 8th day of May, 2018, with the issue:

The Board of Commissioners of Allen County proposes to levy a sales and use tax in the amount of 0.2% for the purpose of providing additional general revenues for necessary acquisition, construction, equipping, or repair of any specific permanent improvement or any class or group of permanent improvements for a period of 10 years, effective October 1, 2018.

Notice is hereby given that in pursuance of a Resolution of the Elida Local School Board of Allen County, Ohio, passed on the 23rd day of January, 2018 there will be submitted to a vote of the people of said subdivision at a Primary Election to be held in the Elida Local School District of Allen and County, Ohio, at the regular places of voting therein, on the 8th day of May 2018, with the question:

Shall the Elida Local School District be authorized to do the following:

- (1) Issue bonds for the purpose of raising the School District portion of the basic project cost and the cost of locally-funded initiatives that do not exceed one-half of the School District's portion of the basic project cost for a Classroom Facilities Assistance Program financing, in the principal amount of \$17,906,447 to be repaid annually over a maximum period of 30 years, and levy a property tax outside the ten mill limitation, estimated by the County Auditor to average over the bond repayment period 2.8 mills for each one dollar of tax valuation, which amounts to \$0.28 for each one hundred dollars of tax valuation, to pay the annual debt charges on the bonds, and to pay debt charges on any notes issued in anticipation of those bonds?

Levy an additional property tax to provide funds for the acquisition, construction, enlargement, renovation, and financing of permanent improvements to implement ongoing maintenance, repair and replacement at a rate not to exceed 0.5 mill for each one dollar of tax valuation which amounts to \$0.05 for each one hundred dollars of tax valuation, commencing in 2018, first due in calendar year 2019, for a continuing period of time?
